The Zone One Show Committee Meeting was called to order at the lunch break at the OPHC's Spring Show by Chairperson Bev Rising.

A Quorum was present

BUSINESS:

2009 Zone One Zone-O-Rama Show

1. **Cattle Classes:** After a discussion of the cattle cost – needing two different kinds of cattle – cutting and roping, award cost, arena cost – two different areas, number of entries at last years show and now at the OPHC Show a motion was made not to have Cattle Classes at the 2009 Zone One Zone-O-Rama. This DOES NOT mean we will not have these classes in the future. Passed
2. **2009 Z. O. Show 4 or 5 days:** The Show Committee looked at the two sheets with a 5 Day Show & a 4 Day Show schedule. After dropping the cattle classes from the schedule – keeping the first (Showmanship & Halter) and last day (Western & Games) the same, moving all the Hunter Hack, Jumping/Hunter, Pleasure Driving & HUS classes to the second day and put Trail, Western Riding and Reining on the third day. There might be a few long days but by cutting out day five there are savings to Z. O. for a full day of pay for all workers, judges, arena rental, hotel rooms, food, etc. A motion was made and passed to have the 2009 Z. O. Zone-O-Rama a four day show.
3. **Days for 2009 Show:** Having the 2009 Z. O. Zone-O-Rama Show on Tuesday – Friday or Wednesday – Saturday – After much discussion a motion was made to start this years 2009 Z. O. Zone-O-Rama on Tuesday and run thru Friday. Passes
4. **Stall Fee:** We will keep the stall fee the same as we had voted it - \$150 – Tuesday – Friday night Day Fee/Haul In Fee - \$30.00 - After August 1 - \$200 & \$50.00. (any stalls rented by the day will be in a special area – per IHP) Motion - Passed
5. **Judges:** Contracts have not been sent out as Shannon was waiting to know the # of days of the 2009 Zone One Zone-O-Rama. Tentative judges are: Gary Hersom, Curt Summers, Marty Jo Hayes, Kelly Boles Chapman, Sam Jackson, Bill French. After the Show Committee changed the 2009 Z. O. Zone-O-Rama Show to four days the Judges Contract need to read 50 hrs & \$2000. Bev will go over changes with Shannon.
6. **APHA Approval:** Shannon will get to APHA now that the dates have been established.
7. **Contract from Idaho Horse Park:** Shannon will get the contract now that we have our dates established – *she will send copy to the board before signing.*
8. **Jump Classes:** It was decided we would have the Jumping & Hunter Hack classes in the outside arena not indoors on the hard arena.
9. **Vendors Form:** Rachel McCart will work with the Idaho Show – Kim Cox – to make sure Joy has a good spot for the Zone One Booth & NOT on the rail.
10. **Zone One Store:** Joy will have items with Zone One Logo on for sale BUT NOT any of the Zone One Awards.
11. **Buckles:** There was a discussion about the buckles from Brenda Wood (cost - \$9650), Frontier and Gist (cost - \$9535 (corrected – 4-10-09) – Gist sent us several samples – after considering all three options a motion was made to purchase the 2009 Z. O. Buckles from Gist – they will not be dated. Passed.
12. **Script:** Edie & Joy will get the Script printed
13. **Post Cards:** Leila has cards all ready but final days. Shannon says they have been working on them. Send out by May 15.
14. **Website:** Shannon says her & Leila have been working on things & Leila will have up & running when she gets the OK.
15. **Hotels:** Shannon will try to get all the judges and staff hotel rooms compt – this will REALLY be a big saving to Zone One.
